My dissertation explores the interactive effects of policy design, administrative burden, and state and local contexts on peoples' ability to access Medicaid benefits between and within U.S. states. To do this, I create a data set of Medicaid policy features and Medicaid policy texts. I compile a database of state-level measures of Medicaidrelated administrative burdens, and I use multilevel regression, imputation, and post-stratification (MRP) to calculate state- and county-level Medicaid policy take-up using administrative and survey data.
